Pre-bid Conference is set October 13, 2023 at 2:00 P.M. at the Bids and Awards Committee, Conference Room, City Legislative Building, 2<sup>nd</sup> floor, Rizal St. corner Hilario St. Ligtasan, Tarlac City.

Interested bidders should submit their duly accomplished bid proposals to the BAC Secretariat not later than 2:00 P.M. on the date of opening of bids. Bid form/s shall be paid directly to the City Treasurer's Office in the amount of P 10,000.00 for the Item No.1 and P 5,000.00 for the Item No. 2-4. Payment of bid form/s is non-refundable.

All other matters not specified herein shall be governed by pertinent provisions of the Revised Implementing Rules and Regulations of Republic Act No. 9184, otherwise known as the "Government Procurement Reform Act".
